TERMS & CONDITIONS**

### AGREEMENTS

- All prices quoted are GST Inclusive.

- It is a policy of Windsor Country Golf Club Limited that groups are not permitted to provide their own food or beverage for Corporate or Charity Golf Days at Windsor Country Golf Club Ltd.

## **BOOKINGS**

- Quotes will remain valid for 30 days from the date of quotation.
- Tentative bookings will be held for a period of 14 days, after which the date will become available.
- To confirm the booking a deposit of \$150.00 is required
- Final payment for food, beverage, and green fees will be required on the day, unless prior arrangement is made.

## **GREEN FEES**

- Will be negotiated with individual clients

## **CONFIRMATION OF A GOLF DAY**

- Bookings must be confirmed in writing and accompanied by a deposit.
- Where written confirmation and the deposit is not received by the due date the Club reserves the right to cancel the booking.
- The deposit required to secure a Golf Day is \$150 including GST.

## **PAYMENT**

- Payment is required on the day of the event unless prior arrangement has been made.

## **CANCELLATIONS**

- In the event of the client wishing to cancel or change the date of a golf day, return of deposit is permitted up until four weeks from the date of play.
- Deposits are not refundable where cancellations are within the four week period.

## **CANCELLATION DUE TO BAD WEATHER POLICY**

- In the event of bad weather, where Windsor Country Golf Club Ltd closes the golf course and declares the course unfit for play: the security deposit will be returned to the client conducting the golf day.
- Catering arrangements will be available to proceed subject to discussion. Where the club has closed the course the client has the option to cancel pre-booked catering arrangements without penalty.

## **CLIENT INSTIGATED CANCELLATION**

- In the event the client wishes to cancel the golf day due to actual or Potential bad weather and where the Club continues to make the course available, the client will be required to pay 100% of the bill.

## **DRESS REGULATIONS**

The Windsor Country Golf Club dress code for golf is aimed at achieving a neat and tidy appearance appropriate to golf: Members and visitors should always appear neat and well dressed: dressing accordingly shows respect for yourself, your Club and the game of golf. Members or guests presenting at the course not dressed appropriately may be refused a start.

- Club policy requires all players be neatly dressed while playing. No irregularly faded or torn clothing is permitted. Apparel must not display offensive designs or slogans.
- Shirts with a collar or be designed as a golf shirt. Singlet tops are not permitted.
- Socks - if wearing shorts, sports socks, ankle length socks or long socks kept pulled up at all times must be worn. No football socks are allowed.
- Shoes - on the course no bare feet, open type footwear, or work boots are allowed.
- Metal spikes are not permitted on the course at any time.
- Not permitted at any time are football jerseys/shorts/socks, offensive shirts, singlets, hats (whilst in clubhouse).

#### **MOTORIZED GOLF CARTS**

- There are 21 motorized golf carts available for hire.
- Group bookings should be made at the time of booking confirmation.
- Individual bookings can be made through the Pro Shop (ph: 02 45773718)
- Current motorized golf cart hire cost \$35.00 inc GST per cart.
- All refreshments are to be purchased from Windsor Country Golf Club Ltd.
- Groups are liable for any damage to carts due to misuse.

#### **SIGNAGE**

- Signage is welcome to be placed on the course.
- All signage will be erected by Windsor Country Golf Club course staff and will need to be delivered to the club 1 week prior to the event. Please leave information on strategic placement of signage with Club staff.
- The Club accepts no responsibility for storage of signage prior to, or after the event.
- The signage must be collected from the course on the conclusion of the day.

#### **CARE OF THE GOLF COURSE**

- All players are required to carry a sand bucket, please repair divots and pitch marks on greens. Sand bunkers must be raked after use.
- Motorized Golf Carts are to be kept at all times 10 meters from Greens where carts paths are not provided.
- No more than two persons are to travel in the Golf Carts at any one time.
- Reckless or careless behavior will not be tolerated and may result in further action being taken placed.

#### **FOOD AND BEVERAGE**

- Food and Beverage must be purchased through Windsor Country Golf Club Ltd. No Food or Beverage purchased elsewhere is to be brought onto the golf course or into the clubhouse.
- Windsor Country Golf Club Ltd has contract caterers who can assist with your menu selection. Copies of menu options are available to assist with the budget for your golf day.
- Confirmation of the number of guests for lunch or dinner will be required one week prior to your event.

#### **LIQUOR LICENSE**

- Windsor Country Golf Club Ltd staff are not permitted to serve alcoholic beverages to patrons who are intoxicated under the Responsible Conduct of Alcohol act.
- Club policy does not allow patrons or guests to bring their own alcohol onto the premises.
- Alcohol cannot be removed from the Club premises and must be consumed in the defined function areas.

#### **CLUBHOUSE DAMAGE**

- The organizer of the event is financially responsible for any damage sustained to Windsor Country Golf Club property during functions.

**SECURITY AND INSURANCE**

- Windsor Golf Club does not accept responsibility for the loss or damage to any property left on the premises prior to, during or after the function.
- It is the organizer's responsibility to take out insurance for all items in their possession should it be deemed necessary.
- Any item that is left in the club MUST be collected within 48 hours of your function.

**COURSE MAINTENANCE STAFF**

- When playing here at Windsor Golf Club at all times players are to give way to the Course Maintenance Staff.
- Under no circumstances are players to hit up on the Course Maintenance Staff. Any player found doing so will be asked to leave the course immediately.
